Dual IT studies at the digital direct insurer

Deutsche Familienversicherung has decided to offer dual training for students of computer science together with its partners, the Technical University of Darmstadt and the Frankfurt University of Applied Sciences.

During the practical phases, students will be trained on-site at Deutsche Familienversicherung in Frankfurt and work directly on the exciting IT projects of the digital direct insurer. The theoretical phases of the course take place at one of the two partner universities. Applicants are free to choose which of the two universities they would like to study at. The programme started at the beginning of the current winter semester on 01.10.2023.
